### New indication for weight loss drug Wegovy

- $\circ~$  Restricts access to morbid obesity only-- this is not the FDA labeling
- Recently FDA approved Wegovy for cardiovascular risk reduction (anyone over 45, overweight or obese, had to have had a heart attack, stroke or limb threatening disease)
  - Medicare is covering it
- $\circ~$  Reduction in spend for this medication in Medicaid may mean we do not have savings
  - Likely around 3,000 people who will be eligible (about 2 million annually in additional spend)
  - When we switched the indication for weight loss we lost the supplemental rebate-- asked Magellan to appeal to manufacturers

- $\circ~$  P&T ad hoc will go over criteria
- Developing criteria for wegovy cardiovascular risk reduction
- Cheryl asks:

- Rate meeting at 2pm
